5. Pre-bid meeting shall be held at Ministry of Internal Affairs and Law, Sudurpashchim State, Dhangadhi, Kailali at 2078/01/05 at 13:00Hrs.
6. Interested Bidders shall submit the electronic Bids through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hrs on 2078/01/12. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2078/01/12 at the office of Ministry of Internal Affairs and Law, Sudurpashchim State, Dhangadhi, Kailali. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 5,25,000.00 which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
